Newsworthy Items

Stylistics and the Sociality of Reading

Stylistic analysis has always made implicit or explicit reference to the reader. As Mick Short writes, '[s]tylistic analysis involves examining carefully the linguistic structure of a text and showing the role which that linguistic structure plays in helping a reader to arrive at an interpretation of that text.'¹ This 'reader' has, however, usually been an ideal or implied reader inferred from analysis of the text being read. More recent interest in 'real readers' has given rise to experimental studies, in which responses to texts or 'textoids' are elicited, often with the aim of testing or shedding light on a cognitive hypothesis or theory. This emphasis is evident, for instance, in a special issue of *Language and Literature* on foregrounding (16; 2; 2007). Another approach is to look at reading as a social phenomenon – i.e. as socially, culturally and historically situated. While this been an analytical focus in research on language and literacy– e.g. New Literacy Studies – it has so far made limited inroads in the study of language and literature. This, however, was the approach taken in the recent AHRC-funded study, *The Discourse of Reading Groups*, carried out at the Open University and drawing on sociolinguistic and corpus linguistic analysis of reading group discussion.² Reading groups form ideal case studies for this sort of research, providing evidence of a

habitual literary practice and allowing researchers to study readers' constructions of interpretations and evaluations of, as well as emotional responses to, literary texts – a kind of natural laboratory, in contrast to the artificial environment of experimental studies. The social nature of reading is the focus of a forthcoming special issue of *Language and Literature* (18; 3; 2009) on 'Literary Reading as Social Practice'.³ This includes papers drawing on both historical and contemporary evidence of literary reading – from historical 'folk stylistics' through contemporary reading groups, school book circles, and mass reading events to the interaction of authors, publishers, and reviewers. We hope the special issue will engender discussion and debate on literary reading and how this may be investigated.
